**GENERAL CONDITIONS**

1. All bids shall be completed on the attached forms supplied by the Technology Center. One (1) copy is to be returned to the Technology Center and one (1) copy retained for your files.
2. **The prices stated shall be net prices and shall include delivery, installation and demonstration.** All prices quoted shall be exclusive of Federal and State Taxes. Exemption certificate, if required, will be furnished to the successful bidder upon request.
3. The work will be performed by 11/1/2023
4. Any bidder submitting a proposal shall specify in writing that the product proposed meets or exceeds the existing product. Schuylkill Technology Center reserves the right to approve to the color of split face brick utilized to for replacement.
5. The Schuylkill Technology Center of Directors reserves the right to waive any informality in the bidding or reject any and all bids submitted and to award the contract in the best interest of the Schuylkill Technology Center using the following rubric:

**Bid Protest Process**

A bidder may protest a bid award if s/he believes that the award was inconsistent with Board policy or administrative regulations or the bid's specifications, or was not done in compliance with law.

The bidder must file a written protest with the Superintendent or designee within five (5) working days after receipt of notification of the bid award. The bidder must submit with the protest, all documents supporting or justifying the protest.

A bidder's failure to file the protest documents in the given time period will constitute a waiver of his/her right to protest the award of a bid.

The Superintendent or designee will review the protest and supporting documents and render a written decision within thirty (30) working days. The Superintendent or designee may arrange a meeting with the protester to attempt to resolve the issue.

The bidder may submit a written appeal of the Superintendent or designee's decision to the Board. The Board will provide reasonable notice to the bidder of the Board's timeline for consideration of the appeal.

The Board's decision will be final.

### **Scope of work**

Proposed paving at the CDL Training Area at the North Campus of Schuylkill Technology Center.

Dimension: 110' x 180' and 45' x 85';

New paved area: 2,625 square yards.

The area had 6" of 2A stone placed, graded, and compacted in 2019.

Work to include excavating, re-grading, and compacting the existing base.

Grade the area adjoining existing paving to allow for placement of 6" of new paving to match the existing paving.

Ensure that a minimum of 6" of 2A subbase is maintained in all paving areas.

New paving:

4-1/2" Superpave Asphalt Mixture, PG 64S-22; Base Course, 25 mm

1-1/2" Superpave Asphalt Mixture, PG 64S-22; Wearing Surface, 9.5mm

All paving work to conform to PennDOT Form 409 Specification as applicable to the work
